1. Who We Are

f. *How Long Your Personal Information Will Be Kept*

We will hold name, address, and contact details for 6 years.

We will hold all non-client personal data until you let us know you would like for us to delete it or unsubscribe from our marketing contacts, which you are free to do at any time. We will hold all client and customer personal data in our files for six years.

g. *Reasons We Can Collect and Use Your Personal Information*

AshleyClairSkywalker.com collects and uses your personal information to send e-mails, fulfill orders, deliver services and products, book sessions, complete customer transactions, oversee contests and promotions and improve website performance and customer service.

4. Use and Transfer of Your Information Out of the EEA, UK
